TERMS AND CONDITIONS of this STALLION SERVICE APPLICATION

1. This mare is booked specifically by name. The booking is valid to the mare named and may not be transferred without consent of Oaklea Farm.
2. Oaklea Farm does not board mares. However, there are several recommended farms close by that provide boarding services. Dr. David Grant is the attending veterinarian at these farms. Please contact Oaklea Farm if you require the services of a boarding farm.
3. Oaklea Farm, its owners, members, employees, or agents shall not be liable or responsible in any manner for any accident or injury, disease or disability suffered by the mare (or her foal). The mare owner acknowledges that the mare (and foal) will be on Oaklea Farm's premises entirely at the mare owner's risk, and waives any and all claims resulting from such injury, disease or disability.
4. The service fee shall be due when the mare produces a live foal (a foal that can stand up alone and nurse) or when the mare changes ownership, whichever occurs first. Should the mare subsequently fail to produce a live foal, upon receipt of a satisfactory veterinary certificate to that effect, Oaklea Farm shall make a full refund of the service fee to the registered owner of the mare on the date the refund became applicable. The Federal 5% Goods and Services Tax will be applicable to service fees, boarding and veterinary charges, etc., and will be added to all invoices. Oaklea Farm's G.S.T. number is 87751 3408.
5. Most of the mares bred to Oaklea Julian will use semen transport. You may pay for semen orders by credit card or cheque. A fee of \$50 + GST will apply for orders picked up at Tara Hills Stud or Glengate Farm. Orders picked up at Oaklea Farm are \$30 + GST. There will be no charge for Equine Express II boxes provided that they are returned promptly. Please fill out the semen transport information below.
